



To Claim Rebate:

1. Purchase any Broyhill dining room set ("Participating Dining Room Set") from an authorized Broyhill Furniture retailer between 10/26/09 and 1/5/10, to receive a \$200 manufacturer's rebate from Broyhill. **The Participating Dining Room Set must be purchased at an authorized Broyhill Furniture retailer.** A Participating Dining Room Set is defined as a table, four chairs and a storage unit, or a table and six chairs. Rebate claims may not be honored until delivery of furniture to the customer has been verified.

2.
